EDUCATIONAL AMENDMENT CERTIFICATE & PURCHASE AGREEMENT

I, _____ agree to purchase permission to use a DVD of JUMP!, originally licensed for Individual Home Use only, (the "DVD") for the following educational purpose according to terms & conditions expressed below.
